Why you are receiving this letter

We reviewed your response to Letter 5039 sent to you on [DATE]. Your response didn't fully address all steps of the Form 14420, *Verification of Reported Income*, nor did it fully explain your unusually low portion of gross receipts from non-card sources of income, including cash and checks.

Either you didn't provide a response to, or clarification is needed for, the following step(s) of the Form 14420:

- Step 1: Form 1099-K verification
- Step 2: Dollar estimates of annual gross sales and annual authorized purchase transactions
- Step 3: Sharing of card terminal(s) with other persons or businesses (only if applicable; however, if there are such persons or businesses listed in the table, please ensure you provide explanations on how they relate to your own in Step 3)
- Step 4: Sales tax
- Step 5: Additional information to explain why non-card sources of income, including cash and checks, seem to account for a lower portion of your reported gross receipts than expected for your type of business and location, given the amount of card payments you received.

Based on the information you provided, there is still an unusually high portion of gross receipts from card payments and other Form 1099-K reportable transactions. Your type of business consistently has between [] % and []% of gross receipts from card payments and other Form 1099-K reportable transactions.

Based on the amount reported on your Form(s) 1099-K, we expect your business to report between \$ [] and \$ [] in gross receipts. What you need to do
